- I specialise in the use of Myofascial Release, Remedial Sports Massage, Deep Tissue Massage and Swedish Massage as well as the Lenton Method™ of Myofascial Release. More details may be found on the Canine Massage Guild website.
- I ensure continuity of client care by providing a written report back to the surgery upon completion of a client's initial sessions.
